DIVER'S LIABILITY RELEASE, ASSUMPTION OF RISK AND HOLD HARMLESS AGREEMENT

I,(Instructor, please print)	, hereby agree as follows:

I knowingly, freely and voluntarily, for myself, my heirs, personal representatives and assigns, hereby waive any and all rights or claims I may have against Lake Denton Management, Inc., Lake Denton Camp, Orange Blossom Baptist Association, and their employees, officers, agents, contractors or assigns (hereinafter "released Parties"), for any and all personal injury, death or property damage I may suffer or sustain as a result of my being on the premises, my participation in scuba and snorkeling activities, and the negligence of the Released parties, whether passive or active. I hereby affirm that I have been well advised and thoroughly informed of the inherent hazards of skin and scuba diving. I agree to dive within the limits of my training and experience.

Further, I understand that SCUBA diving involves certain risks and is inherently dangerous. Injuries can occur that require treatment in a recompression chamber. I hereby assume all risks of injury to myself, including but not limited to, death by drowning or other cause or other accidents such as air embolism, the bends, or other related diving injuries, and to my property, in connection with all diving activities, for any harm that may befall me as a result of my participation in any activity on site, whether foreseen or unforeseen. I still choose to proceed with these activities in spite of the absence of a recompression chamber in close proximity to the dive site.

For myself, my heirs, personal representatives, or assigns, from the date of this agreement and forever hereafter, hold the Released Parties harmless and blameless for any injury to myself, including death, hat may occur as a result of my participation in SCUBA diving activities, however caused including the negligence of the Released Parties. If I, my heirs, personal representatives, or assigns institute any action against the Released Parties arising out of injury to me or damage to my property as a result of SCUBA diving, then in that event, I, for myself and my heirs, personal representatives and assigns, HEREBY AGREE to pay all costs of such action, including attorney's fees incurred by the Released Parties.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parents or guardians. I understand the terms herein are contractual and not mere recital and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights.
